(1) Log Data

Once users use this Service, their IP address, hostname, terminal type, OS type, browser type, and access date and time will be automatically obtained. The above information is used for the purpose of knowing users’ using condition, tailoring the display method of contents, improving service, etc.

3. Specific Prohibitions

During the process of using this Website, the following conducts shall be prohibited:
